Marco Dugato is Senior Researcher at Transcrime and Adjunct Professor of Models Applied to Crime Analysis at the Università Cattolica del Sacro Cuore. He holds a PhD in Criminology and a MA in Sociology. He is founding partner and administrator of Crime&tech, spin-off company of Università Cattolica del Sacro Cuore-Transcrime.



Dr Monica Pons is an MSCA SEAS Postdoctoral Research Fellow at the University of Bergen, specialising in green criminology. Her PhD on glass eel trafficking was recognised by the American and Spanish Societies of Criminology. She currently researches state-corporate crime and marine biodiversity exploitation.



Dr. Gohar Petrossian is a crime scientist, and her research focuses on crimes against wildlife. Dr. Petrossian has published over 75 peer-reviewed articles, book chapters, and monographs on this topic. She is the author of the book *The Last Fish Swimming: The Global Crime of Illegal Fishing*.



Georgios A. Antonopoulos is Professor of Criminology at Northumbria University Newcastle (UK). He is the editor-in-chief of Trends in Organised Crime. He has acted as expert or consultant to the HMRC, the British Police, the Cabinet Office, the US Department of Commerce, the Brazilian Ministry of Justice, and the UNODC.



Ted Leggett has been researching crime for 30 years, including over two decades with UNODC, using a wide range of methodologies. At UNODC, he was responsible for the creation of the Transnational Organized Crime Threat Assessment line of reports and the World Wildlife Crime Report. He is currently working on tobacco trafficking.
